SUBJECT: TENNESSEE VALLEY AUTHORITY: ALLEGED DISCRIMINATION FOR RAISING CONCERNS REGARDING ADHERENCE TO PROCEDURES (OFFICE OF INVESTIGATION CASE NUMBER 2-1999-003)

Dear Mr. Scalice:

Enclosed for your information is the synopsis to the Nuclear Regulatory Commission (NRC) Office of Investigations (OI) completed investigation regarding alleged discrimination by Tennessee Valley Authority (TVA) against a former Stone and Webster Construction Company employee. The individual was employed at the Sequoyah Nuclear Plant, and was allegedly laidoff for raising safety concerns. The OI investigation (OI Report No. 2-1999-003) was completed on March 30, 2000. OI determined that the evidence in this investigation did not substantiate the allegation of discrimination.

On March 8, 1999, the individual also filed a complaint with the U. S. Department of Labor (DOL), Occupational Safety and Health Administration (OSHA) against TVA and Stone and Webster. DOL initiated an investigation on March 15, 2000. Subsequently, NRC was notified by DOL that a settlement had been reached between TVA and the complainant, and that the DOL case was closed. NRC review of the settlement indicated that it met the requirements of 10 CFR 50.7.

Based on the OI conclusions and the resulting settlement prior to conclusion of the DOL OSHA investigation, NRC plans no further action with regard to this matter. Should you have any questions concerning this letter, please contact us.
