By Order dated June 6, 2000, the U.S. Nuclear Regulatory Commission (NRC) approved the transfer of the licenses for the Susquehanna Steam Electric Station (SSES), Units 1 and 2, to the extent held by PP&L, Inc., to PPL Susquehanna, LLC, and approved conforming amendments pursuant to Sections 50.80 and 50.90 of Title 10 of the *Code of Federal Regulations*. The Order was published in the *Federal Register* on June 14, 2000 (65 FR 37418). By letter dated June 20, 2000, the licensee notified the NRC that the closing of the license transfer from PP&L, Inc., to PPL Susquehanna, LLC, will occur on July 1, 2000. By letter dated June 23, 2000, American Nuclear Insurers notified the NRC that PPL Susquehanna, LLC, has obtained the appropriate amount of insurance required under 10 CFR Part 140. This notification satisfies Condition 4 of the June 6, 2000, Order.

Accordingly, the Commission has issued the enclosed Amendment No. 188 to Facility Operating License No. NPF-14 for SSES Unit 1, and the enclosed Amendment No. 162 to Facility Operating License No. NPF-22 for SSES Unit 2. The conforming amendments reflect the transfer of PP&L, Inc.'s ownership of SSES Units 1 and 2 to PPL Susquehanna. The safety evaluation supporting the conforming amendments was attached to the above mentioned Order, issued on June 6, 2000. The Notice of Issuance will be included in the Commission's biweekly *Federal Register* notice.
