By letter dated December 10, 1999, the NRC identified an issue in RAI ITS 3.8.1-01 that was beyond the scope of the Current Technical Specification (CTS) conversion to the Improved Technical Specifications (ITS). The issue relates to proposed changes on the AC Power System. The Electrical & Instrumentation and Controls Branch (EEIB) was requested to evaluate the conversion of CTS 3.9.B.2 to ITS 3.8.1.D which is considered to be outside the scope of the TS conversion program.
