This letter confirms the telephone conversation between Mark Ajluni of your staff and myself concerning a management meeting which has been scheduled for July 11, 2000, from 10:00 to 11:00 a.m. (CDT). The meeting will be held at the Farley Nuclear Plant Visitors Center Auditorium. The purpose of the meeting is to discuss two white performance indicators (PI) in the Farley Unit 2 Mitigating Systems Cornerstone for the second quarter of calendar year 2000. Two white PIs is considered a degraded Mitigating Systems cornerstone on Unit 2. Per our Reactor Oversight Process Action Matrix, a management meeting is required to discuss any performance deficiencies and your corrective action plan in response to a degraded cornerstone. My previous letter dated June 26, 2000, delineated our plan to conduct supplemental inspections to better understand the causes contributing to this issue. The meeting will be an open meeting as per "Staff Meetings Open to the Public; Final Policy Statement" (September 20, 1994; 59 FR 48340).
