I also discussed at the June 1 meeting what we plan as the NRC involvement in MIDAC meetings. We envision providing updates on the decommissioning status of Millstone 1 approximately quarterly, depending on the availability of NRC staff and resources. This is consistent with the position that Region I has taken at other decommissioning power reactors within our jurisdiction.
