### **Changes to the Federal Register Notice in COMSECY-00-0028**

1. On page 1, in the 'ACTION' and 'ADDRESS' sections, remove the accent mark from the first 'e' in 'resumés'. Make the same correction in line 1 on page 3.
2. On page 1, last paragraph, revise line 2 to read ' ... on matters related to **licensing regulatory policy** and the safety of ....'
3. On page 1, last paragraph, ensure the statement of the Committee's emphasis is conveyed consistently in the FRN and the press release.
4. On page 1, last paragraph, revise line 5 to read ' ...pursuit of a risk-informed ; and ~~ultimately, as appropriate,~~ performance-based regulatory approach; **review of license renewal applications**; digital ....'
5. On page 1, last paragraph, revise line 6 to read ' ... systems; and technical ~~and policy~~ issues related to ....'
6. On page 2, 1<sup>st</sup> paragraph, revise the next to last line to read ' ... mechanics/materials engineering and metallurgy **applicable to nuclear power systems**; and **the application of** risk methods ~~application~~ related ....'
7. On page 2, 2<sup>nd</sup> paragraph, revise the last 2 lines to read ' ... ~~varying views~~ **diverse viewpoints** so that membership on the Committee will be fairly balanced in terms of the ~~points of view represented and functions to be performed by the Committee~~ .
8. On page 3, next to last line, reconcile the estimate of days required to support Committee business to the numbers in the press release.

9. On page 1, paragraph 2, ensure the statement of the Committee's emphasis is conveyed consistently in the FRN and the press release.
10. On page 1, paragraph 3, revise line 4 to read ' ... mechanics/materials engineering and metallurgy **applicable to nuclear power systems**; and ....'
11. On page 2, in the 1<sup>st</sup> line of the last 2 paragraphs, remove the accent mark from the first 'e' in 'resumés'.
12. On page 2, next to last paragraph, next to last line, reconcile the estimate of days required to support Committee business to the numbers in the FRN.
13. On page 2, next to last paragraph, insert the following sentence after the 1<sup>st</sup> sentence: '**Criteria used to evaluate candidates include education and experience, demonstrated skills in nuclear safety matters, and the ability to solve problems.**'
14. On page 2, revise the last line to read ' ... Washington, D.C., 20555-**0001**.'
