Dear Mr. Mueller:

On March 2, 2000, we issued Amendment No. 92 to the operating license of NMP2. By letter dated June 13, 2000, Niagara Mohawk Power Corporation informed us of a number of administrative errors in that amendment. We reviewed those errors and confirmed the validity of your proposed corrections as follows:

You pointed out that the second page of the deletion/insertion document attached to Amendment No. 92 missed a number of entries and incorrectly characterized others. We agree with your proposed corrections but found that the errors originated from the absence of proper deletion/insertion instruction in your February 7, 2000, submittal which provided revised ITS pages. Enclosed please find a corrected page 2 of the deletion/insertion document, which is done in comparative text form for easy identification.

You indicated that Note 3 to Surveillance Requirement 3.3.1.1.13 (page 3.3.1.1-6 of the Improved Technical Specifications (ITS) portion of Amendment No. 92) contains a typographical error, such that the acronym for Oscillation Power Range Monitor, OPRM, was inadvertently typed as ORRM. We agree with this observation and have reissued a corrected page (enclosed).

You indicated that though the staff issued Basis page B 3.3.1.1-22 to you by facsimile, the page was missing from the mailed version (i.e., hard copy) of Amendment No. 92.
