Dear Mr. Ratliff:

We have reviewed the final Texas Regulations for Control of Radiation (25 Texas Administrative Code 289) Sections 210 and 202 adopted in February 2000 which became effective on March 30, 2000 and Section 257, also adopted in February 2000 that will become effective on October 1, 2000. The regulations were sent on April 5, 2000. The final regulations are in response to the six amendments identified in the enclosed Regulations Assessment Tracking System (RATS) Data Sheet. The regulations were reviewed by comparison to the equivalent NRC regulations in 10 CFR Parts 20 and 71. We also discussed our review of the regulations with Ms. Cindy Cardwell on June 1, 2000.

As a result of the NRC review, we have determined that the Texas Bureau of Radiation Control (BRC) regulations, as adopted, meet the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure SA-200.

We have also summarized on the RATS Data Sheet our knowledge of the status of other BRC regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the RATS Data Sheet.
