On May 11 and 12, 2000, the Power Authority of the State of New York, Entergy Nuclear Operations, Inc., Entergy Nuclear FitzPatrick, LLC, and Entergy Nuclear Indian Point 3, LLC, filed applications seeking the Commission’s approval of the transfer of the facility operating licenses for the two above-captioned facilities.
