MEMORANDUM

(Notice Regarding Issuance of Decision
on Summary Disposition and Discovery
Motions Regarding Contention Utah H)

By memorandum and order issued this date, the Licensing Board has ruled on pending partial summary disposition and discovery motions regarding contention Utah H. See LBP-99-42, 50 NRC ____ (Nov. 2, 1999). In that decision, the Board (1) denied a May 19, 1999 partial summary disposition motion filed by applicant Private Fuel Storage, L.L.C., (PFS); (2) directed the parties to take further action relative to the April 30, 1999 motion of intervenor State of Utah (State) to compel discovery regarding that contention; and (3) requested additional information from the parties concerning litigation of this contention and other issues potentially involving the use of proprietary information,

At present, the Board's decision is being treated as not subject to public release. Accordingly, copies are being provided only to the State, PFS, and the NRC staff.¹ In crafting its decision, however, the Board has attempted to avoid the use of proprietary information not subject to public disclosure in accordance with 10 C.F.R. § 2.790 so that this issuance can be made part of the public record of this proceeding. To confirm there are no problems in this regard, we have requested that these three parties inform the Board in a joint filing to be submitted by Wednesday, November 10, 1999, of their view as to whether any portion of the decision is not subject to public disclosure.

Once the Board has received a response from these parties, it will make a final determination about whether its contention Utah H decision, or portions of that decision, can be made part of the public record of this

proceeding. The parties will be advised of the Board's ruling in this regard.


