To accomplish and document the origin exchange, the U.S. facility involved in the exchange must complete and submit DOE/NRC Form-741 to the Nuclear Materials Management and Safeguards System (NMMSS) located in Norcross, Georgia. Please note that the Russian origin nuclear material in your request may be subject to trade quotas or restrictions. You must address that issue with the Department of Commerce separately.
