We have reviewed the information you provided and approve a waiver to meet the experience requirements for the licensed limited senior reactor operator (LSRO) to enter the senior reactor operator license training program which is a systems approach to training program. Upon meeting the training program requirements, the candidate may apply for a senior operator license examination. Since the LSRO is not required to pass a Generic Fundamentals Examination (GFE), the GFE must be passed prior to applying for a senior reactor operator examination.
