On behalf of Seaman, you requested: (1) a copy of SECY-00-0137, an information paper prepared for the Commission by the staff; (2) that Seaman be given an opportunity to comment on the paper before any action that would affect Seaman is taken; and (3) that Seaman be given an opportunity to meet with members of the NRC staff and the Commissioners' technical staff.

The SECY paper that you have requested has not been made publicly available, pending a staff decision on the Seaman application, because the paper contains pre-decisional information. As you note in your letter, in January of this year, Seaman had an opportunity to submit additional comments on matters related to its application.
