To the Secretary of the Commission:

Today, pursuant to the Atomic Safety and Licensing Board's Order of June 12, 2000, Private Fuel Storage ("PFS") is submitting revised testimonies of certain of its witnesses and supporting exhibits for the June 2000 evidentiary hearings in the above referenced proceedings. 


