Dear Ram,

In a telephone conversation conducted on July 10, 2000, you requested that the Core Operating Limits Report (COLR) contain the date of the approved version of each referenced topical report. Upon implementation of the requested change to Technical Specification (TS)5.6.5, "Core Operating Limits Report (COLR), the COLR will specify the approved version of the referenced topical reports, including the date of the report.

Also yesterday, Harold K. Chernoff and I, in discussions with you, indicated that the analyses for HBRSEP, Unit No. 2 in accordance with the new methodologies requested in the proposed TS change are currently in progress but are not completed. When the amendment is approved, rather than specify a specific time frame associated with implementation (i.e., 39 days), please issue the amendment requesting that CP&L notify the NRC within 30 days of implementation of the amendment. Thank you.
