

This letter provides documentation (attached) which supports the ANI letter (reference 1), that was submitted to the NRC as part of the NRC's review and approval of the Susquehanna SES 10CFR50.80 license transfer amendment requests. The license transfer amendments were approved on June 6, 2000 (reference 2) and issued on July 1, 2000 (reference 3). This letter also serves as the annual notification of PPL Susquehanna, LLC's guarantee of payment of deferred premiums pursuant to 10CFR140.21.



Also, 10CFR140.21 requires that PPL Susquehanna, LLC annually provide evidence for the guarantee of payment of deferred premiums. The ANI letter (reference 1) in conjunction with the supporting documentation being provided as an attachment to this letter, and the SER associated with the amendment approving the 10CFR50.80 license transfer (reference 2) provides satisfactory evidence of PPL Susquehanna, LLC's guarantee of payment of deferred premiums for the year 2000.

Since PPL Susquehanna, LLC guarantees assessments against Allegheny Electric Cooperative, Inc., only PPL Susquehanna, LLC should be invoiced for the annual fee.
