Prior to joining the Spent Fuel Project Office, Mr. Temps qualified as an NRC Resident Inspector in Region I as described in NRC Manual Chapter 1245. Mr. Temps achieved resident inspector certification in April 1989. Since Mr. Temps was previously certified as an inspector, NRC Manual Chapter 1246 requires him to be trained only in those areas that differ from his past experience. Specifically, Mr. Temps was required to take H-308, "Transportation of Radioactive Materials," and to participate in three inspections of transportation activities. Mr. Temps completed the H-308 training on June 25, 1999, and has since participated in four team inspections of transportation activities under the tutelage of qualified TSIS inspectors. Mr. Temps was also the sole SFPO representative during a recent Region II team inspection at Plant Hatch where he assessed the quality of the licensee's 10 CFR 72.212(b) evaluations for their generally licensed ISFSI. In all cases, the lead inspector reported that Mr. Temps' performance and abilities were of acceptable quality.

I therefore recommend that Mr. Temps be granted full certification as an NMSS Headquarters Transportation and Storage Safety and Inspection Section Safety Inspector.
