Dear Mr. Jacobi:

We have reviewed the final amendments to the Colorado Rules and Regulations Pertaining to Radiation Control, i.e., Part 4 - Standards for Protection Against Radiation, which became effective on December 30, 1999, Part 1- General Provisions, Part 3 - Licensing of Radioactive Material, and Part 5 - Radiation Safety Requirements for Industrial Radiographic Operations, which became effective on May 30, 2000. The regulations were submitted by memorandum dated June 29, 2000. The final regulations are in response to the three amendments identified in the enclosed Regulation Assessment Tracking System (RATS) Data Sheet. The regulations were reviewed by comparison to the equivalent NRC regulations in 10 CFR Parts 20 and 34. In addition, we reviewed our October 1, 1999, and March 24, 2000, letters to you that addressed the proposed regulations. We discussed our review of the regulations with you on July 27, 2000.

As a result of the NRC review, we have determined that the Colorado regulations, as adopted, meet the compatibility and health and safety categories established in State and Tribal Programs Procedure SA-200.

We have also summarized on the RATS Data Sheet our knowledge of the status of other Colorado regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the RATS Data Sheet.
