


The purpose of this modification is to exercise the First Option Year under the contract and provide additional funding. Accordingly, the following changes are hereby made to the contract terms and conditions:

1. Section B.2 CONSIDERATION AND OBLIGATION - - DELIVERY ORDERS, paragraph (a) is revised by increasing the total estimated amount of this contract (ceiling) to \$485,000.00.
2. Section B.2 CONSIDERATION AND OBLIGATION - - DELIVERY ORDERS, paragraph (b) is revised by increasing the amount presently obligated by \$120,000.00 from \$360,000.00 to \$480,000.00.
3. Section B.3 52.216-18 ORDERING (OCT 1995), paragraph (a) is revised by extending the ordering period of the contract through August 31, 2001.

All other terms and conditions of the contract remain unchanged.
