**SUBJECT: MODIFICATION NO. 2 TO TASK ORDER NO. 1 ENTITLED, "REVIEWING THE NONSTANDARD FINANCIAL ASSURANCE SUBMITTALS OF NRC LICENSES" UNDER CONTRACT NO NRC-02-00-001**

Dear Ms. Schossow:

In accordance with the Section G.5, Task Order Procedures, of the subject contract, this letter definitizes modification number 1 to Task Order No. 1. This effort shall be performed in accordance with the Contractor's proposal dated May 16, 2000, which is incorporated by reference and made a part of this task order. Verbal authorization to proceed with performance of this effort was given by the Contracting Officer on May 12, 2000 with a not to exceed spending limits of \$20,000.

The purpose of this modification is to: (1) increase the estimated level of effort by 1225 professional hours from 640 professional hours to 1865 professional hours. This increase is necessary due to the increase in the estimated level of effort required to complete the financial review of the United States Enrichment Corporation's (USEC) from 32 professional hours to 1225 professional hours. This effort includes increasing the scope of the financial review by expanding to: fully consider two (2) sets of financial data submitted by USEC; more detailed financial modeling for the development of independent pro-forma financial statements; and evaluation of additional scenarios to fully address the viability issues pertinent to Congressional concerns and additional ICF effort is also needed to support internal NRC management reviews of the Commission Paper that will present the results of the financial review; (2) the task order ceiling amount is increased by \$115,357, from \$58,314 to \$173,671; and (3) provide incremental funding in the amount of \$104,500 thereby increasing the obligated amount from \$57,419 to \$161,919. Accordingly, the task order is hereby modified as follows:

The second and fourth paragraphs of the definitization letter are deleted in their entirety and the following is substituted in lieu thereof:

Task Order number 1 shall be in effect from February 9, 2000, through February 8, 2001, with a cost ceiling of \$173,671. The amount of \$159,331 represents reimbursable costs. The amount of \$14,340 represents the fixed fee.

This task order obligates funds in the amount of \$161,919, of which \$148,550 represents reimbursable costs and \$13,369 represents the fixed fee. Accounting data for this task order modification is as follows:


