The purpose of this modification is to decrease the amount obligated in the contract by \$2,213.29 from \$152,500.00 to \$150,286.71. Accordingly, the contract is hereby modified as follows:

Section B, Subsection B.4, Consideration and Obligation-Work Orders, paragraph b, first sentence, is deleted in its entirety and substituted with the following in lieu thereof:

"b. The amount presently obligated with respect to this contract is \$150,286.71."
