a. MOA's between Lawrence Berkeley Laboratory and Water Resources Division of USGS for work performed in support of USGS participation in the YMP for scientific work. The MOA's were reviewed and Supplements 1 and 2 were issued for MOA25A and Supplement 1 for MOA51 which specify the technical procedures.

b. Verified by review that MOA's 55, 56, 57 and 66 included the technical procedures (as appropriate) in Attachment 1.

- MOA 55 - included GP-01, Rev. 2 and GP-52, Rev. 0
- MOA 56 - included GP-01, Rev. 2 and GP-52, Rev. 0
- MOA 57 - included GCP-03, Rev. 3
- MOA 66 - included GP-12, Rev. 1

Verified MOA's 49, 52, 59, 61 and 63 did not require the inclusion of technical procedures in the MOA's.

EXTENT OF THE DEFICIENCY -

a. The MOA's in effect in February were reviewed for impact in accordance with the CAR (MOA's 25, 19, 50, 51, 52, 53, 54, 55, 56, 57, 58, 59, 60, 62, 63 and 66) of the MOA's 25, 50, 51, 55, 56, 57 and 66 were changed by supplements issued specifying the appropriate technical procedures.

b. USGS issued a USGS QDR-95038-2 which documents MOA's issued after February requiring reviews to incorporate technical procedures specific to the activity. These MOA's have a QA Review Sheet attached to them, notifying the requestor's that a review was required for MOA's 61, 67 thru 71, 83, 84, 86, 87 and 88.

CORRECTIVE ACTION TO PRECLUDE RECURRENCE - Verified YMP-USGS-QMP-4.02, Rev. 6, Control of Agreements, Attachment I, Subsection F, Technical Requirements specified that technical procedures or instructions are required to be specified.
