**PROGRAM MANAGEMENT INFORMATION: TECHNICAL CONFERENCING FORUM -
REQUEST FOR COMMENTS ON DRAFT TEMPORARY INSTRUCTION, "INSPECTION OF
EXPOSURE MONITORING, ESTIMATING, RECORDING AND REPORTING" (STP-00-068)**

The U.S. Nuclear Regulatory Commission (NRC) is proposing to issue a Temporary Instruction (TI) on inspection of exposure monitoring, estimating, recording and reporting. This effort was undertaken due to recent events involving overexposures as a result of improper handling of Radiopharmaceuticals.

The draft TI, "Inspection of Exposure Monitoring, Estimating, Recording and Reporting," which is undergoing NRC office review and comment has been uploaded to the Technical Conferencing Forum (TCF). Because of the nature and type of overexposures, we would like to issue this TI as promptly as possible. We would appreciate your review and comment on this draft TI no later than one week from the date of receipt of this document. We recognize that the relatively short review and comment time may not be convenient for you. However, due to the tight schedule, in parallel with your review, NRC offices have about the same amount of time to review and comment on this draft TI. The TCF can only be accessed by the Agreement States having a unique user name and password, which was last updated via All Agreement States letter SP-99-027.
