Ladies and Gentlemen:

Re: Submittal of Documentary Evidence of Insurance  
Nuclear Management Company, LLC

By letters dated May 15, 2000, the Nuclear Regulatory Commission issued Orders to IES Utilities, Inc., Northern States Power Company, Wisconsin Electric Power Company and Wisconsin Public Service Corporation, approving the transfer of operating authority under facility operating licenses held by these four utility companies to Nuclear Management Company, LLC (NMC). The Orders also approved conforming license amendments, which will be issued and made effective at the time the transfers are completed.

The Orders approved the proposed transfers subject to two conditions. Condition (2) in each of the Orders requires:

NMC shall, prior to the completion of the transfer of operating authority for [Point Beach Nuclear Power Plant, Duane Arnold Energy Center, Monticello Nuclear Power Plant, Kewaunee Nuclear Power Plant, Prairie Island Nuclear Power Plant], provide the Director of the Office of Nuclear Reactor Regulation satisfactory documentary evidence that NMC has obtained the appropriate amount of insurance under 10 CFR Part 140 of the Commission's regulations.

Attached are Certificates of Insurance which provide documentary evidence that NMC has obtained the appropriate amount of insurance as required of licensees under 10 CFR 140.
