Due to IES Utilities Inc. transferring operating authority for the Duane Arnold Energy center (DAEC) to the Nuclear Management Company, LLC (NMC), changes to the security organization occurred which affected the DAEC Security Plan. These changes were effective on August 7, 2000 and the DAEC Security Plan has been revised accordingly. The changes have been made pursuant to 10 CFR 50.54(p).

This Security Plan Change (SPC-42) has been reviewed in accordance with the requirements of 10 CFR 50.54(p). We have determined that the changes do not decrease the effectiveness of the DAEC Security Plan. A description of the changes is included in Attachment 1 and our evaluation is included in Attachment 2 to this letter. The revised Security Plan is included as Attachment 3.

The attachments to this letter contain information of the type described in 10 CFR 73.21; therefore, they should be withheld from public disclosure.
