SUBJECT: OBSERVATION AUDIT OF SCIENCE APPLICATIONS INTERNATIONAL CORPORATION

This letter transmits the U.S. Nuclear Regulatory Commission (NRC) Observation Audit Report No. 92-12 for the U.S. Department of Energy (DOE), Office of Civilian Radioactive Waste Management, Yucca Mountain Quality Assurance Division (YMQAD) Quality Assurance (QA) Audit No. YMP-92-16 of the Science Applications International Corporation (SAIC)/Technical & Management Support Services (T&MSS) QA program conducted in Las Vegas, Nevada from May 18-22, 1992. The audit scope was limited to six QA program elements and two technical areas evaluated by QA programmatic and technical specialists.

The NRC staff evaluated the audit to gain confidence that DOE/YMQAD and SAIC/T&MSS are properly implementing the requirements of their QA programs. The NRC staff based its evaluation of the audit process and the SAIC/T&MSS QA program on direct observations of the auditors, discussions with the audit team and SAIC personnel, and reviews of the pertinent audit information (e.g., audit plan, checklists, and SAIC/T&MSS documents).

The NRC staff has determined that Audit No. YMP-92-16 was useful and effective considering the limited amount of quality-affecting work available to be audited. The audit was well organized and conducted in a professional manner with minimal logistic delays. The audit team was well prepared and its checklist items were adequately described in the audit plan. Some technical areas were audited for compliance to procedural controls (e.g., radiological monitoring and meteorology), but no evaluation of the technical work products was made by the NRC staff Observation Team members.

The NRC staff has determined that the audit was effective, and agreed with the DOE/YMQAD audit team that implementation of the SAIC/T&MSS QA program was satisfactory for five of the six QA program elements that were audited. The NRC staff also agreed with the DOE/YMQAD audit team that Criterion 12, "Control of Measuring and Test Equipment," was marginally effective in its implementation. This will not have a significant impact in the overall implementation of Criterion 12. Two preliminary Corrective Action Requests were issued by the DOE/YMQAD audit team, one in the area of calibration, and the other in the area of training. These deficiencies are not significant in terms of the overall QA program and did not affect the quality of any SAIC/T&MSS site characterization activities.
