Florida Power and Light Company (FPL) is preparing an application for the renewal of the operating licenses for Turkey Point Units 3 and 4, issued under Section 104 of the Atomic Energy Act of 1954, as amended. FPL plans to submit the Application to the Nuclear Regulatory Commission by Fall of 2000 pursuant to the requirements of 10 CFR 54.17. The planned Application will include an environmental report prepared and filed pursuant to 10 CFR 54.23 and the requirements contained in Subpart A of 10 CFR Part 51.

Submittal for Sufficiency

As required by 10 CFR 2.101(a), 50.4(b)(3), 50.30(a)(6), and 51.55(a), FPL plans to file the signed hardcopy original of the Application (including the Applicant's Environmental Report - Operating License Renewal Stage) and thirteen (13) copies to the NRC Document Control Desk, and one (1) copy of the same to the NRC Regional Administrator. FPL plans to also transmit ten (10) copies of flow diagrams (not considered part of the application) to aid the NRC staff review of the Application to the NRC Document Control Desk, and one (1) copy of the same to the NRC Regional Administrator. One (1) courtesy copy of the Application and flow diagrams will also be provided to the NRC Senior Resident Inspector for Turkey Point. FPL plans to also file twenty-six (26) additional copies of the Applicant's Environmental Report - Operating License Renewal Stage, to the NRC Document Control Desk. All copies of this submittal will be in hardcopy form and will serve for the determination that the Application is suitable for docketing pursuant to 10 CFR 50.30(a)(6).

Docketing of the Application

Upon receiving NRC notification that the Application is complete and acceptable for docketing, FPL plans to file twenty-six (26) additional copies of the Application (including the Applicant's Environmental Report - Operating License Renewal Stage) as required by 10 CFR 2.101(a)(3), 50.4(b)(2), 50.30(a), and 51.55(a), and all additional copies in accordance with the requirements directed by the above regulatory requirements and the written instructions furnished with the acceptance for docketing notice by the NRC. Additional copies of the Applicant's Environmental Report - Operating License Renewal Stage will be provided as requested. One (1) copy of the docketed Application will be provided to the NRC Senior Resident Inspector for Turkey Point as required by 10 CFR 50.4(b)(2)(ii). Additional copies of the docketed Application will be provided to the NRC Regional Administrator as requested.

All copies of the docketed Application discussed above will be in electronic form as a CD-ROM (Compact Disk - Read Only Memory) which will include:

- The Application including the Environmental Report
- Turkey Point Units 3 and 4 Updated FSAR
- Flow Diagrams

FPL plans to work with the NRC Staff to define the appropriate compact disk medium that is accessible to the NRC. Copies in CD-ROM form will aid the reviewers and interested parties by providing timesaving electronic search capability. Providing the Application in this form is also consistent with recent NRC efforts in support of electronic submittal of documents.

In addition, in accordance with the requirements of 10 CFR 50.30(a)(2) and 51.55(a), copies of supporting information will be retained by FPL for distribution in either paper or electronic file form upon request from the NRC. Any additional copies of the Application for Federal, State, and local officials or other interested parties that are requested by the NRC as specified in 10 CFR 2.101(a)(3)(iii), 50.30(a), and 51.55(a) are planned to be provided in CD-ROM form unless a paper copy is requested.

Similarly, updates to the Application required by 10 CFR Parts 2, 50, 51, and 54 are planned to be provided in CD-ROM form. FPL understands that all interested parties requesting copies may not be equipped to use CD-ROMs. In these cases, FPL will distribute copies of the application and supporting information to the interested parties in paper form, as appropriate.

Determination of Exception Pursuant to 10 CFR 50.4(c)


