- Video tape of the rainstorm of August 11, 1992.
- Precipitation data for the rainstorm of August 11, 1992. Please provide the data as the the complete time-depth (amount) or time-rate data for recording raingages and total depth amounts for standard (non-recording) gages on either 3 1/2" or 5 1/4" disks in a specified file format.
- A copy of "FY'93 Annual Plan for Site Characterization," text and appendices, dated January 31, 1993.
- JAB-10733-TM6, US-703, Processed Seismic Motion Records (Skull Mountain)

In addition, the staff requests a copy of "FY'94 Annual Plan for Site Characterization," when available.
