Dear Mr. Whatley:

We have reviewed the final amendments to the Alabama Regulations for Control of Radiation, Chapter 420-3-26, which became effective on May 25, 2000. The regulations were sent on July 17, 2000. The final regulations are in response to the eleven amendments identified in the enclosed Regulation Assessment Tracking System (RATS) Data Sheet. The regulations were reviewed by comparison to the equivalent NRC regulations in 10 CFR Parts 20, 30, 32, 34, 35, 36, 39, 40, 61, 70, and 150. We also reviewed the final amendment to Chapter 420-3-26-.07 concerning the definition, notification, reports, and records of misadministrations that Alabama adopted on December 18, 1996. Mr. Woodruff of our Region II office discussed our review of the regulations with you on August 10, 2000.

As a result of our review, we have determined that the Alabama Regulations for Control of Radiation, Chapter 420-3-26, as adopted, meet the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure SA-200.

We have also summarized on the RATS Data Sheet our knowledge of the status of other Alabama regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the RATS Data Sheet.
