

Contract No. NRC-10-96-155 is hereby modified to provide for an equitable adjustment of the contract price resulting from the following deductive changes to the scope of work:

1. The contractor shall retain the existing ceiling grid in the following rooms of the One White Flint North building. The downward adjustment for this change is \$10,021.

As a result of this decrease in the scope of work, the contract price is reduced. However, the funds shall remain in the contract for other equitable adjustments.

Section B.4 CONSIDERATION AND OBLIGATION—FIRM FIXED PRICE is modified to decrease the fixed price of the contract by \$10,979 from \$5,501,497 to \$5,490,518.

Except as provided herein, all other terms and conditions of the contract remain unchanged and in full force and effect.
