

The purpose of this modification is to (1) incorporate a change to the statement of work to reduce the number of members required for the cleared personnel pool, pursuant to the MSTI letter request dated July 20, 2000, and (2) replace [REDACTED] with [REDACTED] as one of the key personnel under the contract. Accordingly, the contract is modified as follows:

1. Section C.6, "Maintenance of Personnel Pool" is hereby deleted in its entirety and substituted with the following:

"The contractor shall maintain a pool of four (4) employees who have been granted NRC security clearance. Of the four staff members in the pool, two shall be identified as key personnel under Section H.3 and shall be available for duty during all Federal work days at the NRC Headquarters site. The remaining two members in the pool shall be available (as needed) to provide support in the absence of the key on-site personnel. All employees assigned to perform services under this contract shall be drawn from this pool. The contractor shall promptly advise the project officer when an employee in the pool has terminated his or her employment relationship with the contractor. See Clause H.5, "Security," herein. The contractor's responsibility to maintain a pool of four (4) employees who have been granted clearance in accordance with this clause is of the essence of this contract. Therefore, any failure on the part of the contractor to satisfy this requirement shall be grounds for default termination."

2. Section H.3, "NRCAR 2052.215-70, Key Personnel (JAN 1993)" paragraph (a) is hereby deleted in its entirety and substituted with the following:

"The following individuals are considered to be essential to the successful performance of the work hereunder:

The contractor agrees that personnel may not be removed from the contract work or replaced without compliance with paragraphs (b) and (c) of this section."

All other terms and conditions of this contract remain unchanged.
