


This contract modification is being executed pursuant to the NRC's MOU with SBA with permits bilateral execution of contract documents. The purpose of this contract modification is to change the contract period of performance of Contract Line Item No. (CLINs) 9, 10, 13 and 14 to a month-to-month optional basis to coincide with CLINs 12 and 15 and to extend the contract period of performance to October 31, 2000 at the prices set forth at Section A.4 for CLINs 9, 10, and 12 for the period 10/1/00 to 9/30/01. Accordingly, the contract is hereby modified as follows:

1. Section A.4 of the contract is changed to read as follows for the periods 10/1/00 to 9/30/01 and 10/1/01 to 9/30/02:

3. Section B.15 of the contract is changed to read as follows:

B.15 DURATION OF CONTRACT.

The contract commenced on 9/30/97 and will expire on 10/31/2000. The term of the contract may be extended at the option of the Government on a month-to-month basis by single months or in groups of months through 9/30/02.

4. CLINs 9, 10 and 012 are hereby exercised for one month (10/1/00 thru 10/31/00). AS a result, the total firm fixed price of the contract set forth in Section B.2 is increased by \$13,660.48 from \$590,548.41 to \$604,208.89.
