On January 11, 2000 one short-term contractor tested positive for marijuana on a pre-access drug/alcohol screen. The contractor was not allowed unescorted access and was provided an opportunity to appeal through the Wisconsin Electric appeal process. There was no appeal and unescorted access was denied.

On January 17, 2000 one short-term contractor tested positive for cocaine on a pre-access drug/alcohol screen. The contractor was not allowed unescorted access and was provided an opportunity to appeal through the Wisconsin Electric appeal process. There was no appeal and unescorted access was denied.

On February 01, 2000 one short-term contractor was selected for a random drug alcohol screen. On February 11, 2000 results of the drug screen were confirmed positive for methamphetamine. The contractor's unescorted access was terminated. The contractor appealed the removal of unescorted access according to the Wisconsin Electric appeal process. The drug screen was sent to a second laboratory that confirmed the results of the initial test. The appeal for unescorted access reinstatement was denied.

On April 24, 2000 one short-term contractor tested positive for marijuana on a pre-access drug/alcohol screen. The contractor was not allowed unescorted access and was provided an opportunity to appeal through the Wisconsin Electric appeal process. There was no appeal and unescorted access was denied.
