Enclosed for your information and retention are ten copies of the most recent edition of the Yucca Mountain Site Characterization Project Technical Data Catalog (YMP TDC) dated June 30, 1993. This document is updated and released quarterly in accordance with the U.S. Department of Energy/U.S. Nuclear Regulatory Commission (NRC) Repository Project-Specific Agreement of 1993.

The catalog contains a listing of data collected in the course of characterizing Yucca Mountain, Nevada, as a potential site for a high-level radioactive waste repository. This version of the catalog is a quarterly supplement and contains information submitted to the project Automated Technical Data Tracking System since April 1, 1993. A complete revision of the catalog will be published at the end of each fiscal year. The December 31, 1992, edition of the YMP TDC should be retained and used as the baseline document until the next complete revision is published in October of this year. The catalog and supplements contain information submitted to the project Automated Technical Data Tracking System since March 29, 1990. Information related to data items connected for YMP prior to that date are being added to the catalog as time and funding allow.
