Dear Ms. Lee:

I refer to the letter from your office dated May 30, 2000 requesting the views of the Executive Branch as to whether issuance of an export license in accordance with the application hereinafter described meets the applicable criteria of the Atomic Energy Act of 1954, as amended:

NRC No. XSNM03149—Transport Logistics International. Inc. has applied for authorization to export to Japan 57.67 kilograms of U-235 contained in 7,300 kilograms of uranium enriched to a maximum of 0.79 percent in the form of uranium dioxide for reload of the 165 Mwe Fugen Advanced Thermal Reactor uranium/plutonium fueled reactor owned and operated by the Japan Nuclear Cycle Development Institute.

It is the view of the Executive Branch that the proposed export will not be inimical to the common defense and security of the United States, and is consistent with the provisions of the Atomic Energy Act of 1954, as amended.

The proposed export to Japan would take place pursuant to the 1988 Agreement for Cooperation Between the United States and Japan, as confirmed in Japan Ministry of Foreign Affairs Note No.179 dated August 24, 2000, a copy of which is enclosed.

On the basis of the foregoing, the Executive Branch recommends that the license be issued.
