Westinghouse Purchase Orders are identified as 45000XXXXX, 44000XXXXX or SAMBXXXXXX. An invoice that represents a number such as 46000XXXXX is a value contract and not a purchase order. We cannot pay an invoice that references a value contract. Please contact the Westinghouse individual who ordered the goods or services for a valid purchase order number. If you are inquiring about more than 5 invoices, please email or fax to (412-256-5251) a list of the invoices with the information noted above.

We appreciate if inquiries were limited to when payment is beyond the terms of the purchase order. The standard payment terms of Westinghouse are:

- ◆ Invoices dated the 1st through the 10th of the month will be paid and the check mailed on the 25th of the following month of the date of the invoice.
- ◆ Invoices dated the 11th through the 20th of the month will be paid and the check mailed on the 5th of the second month following the date of the invoice
- ◆ Invoices dated the 21st through the 31st of the month will be paid and the check mailed on the 15th of the second month following the date of the invoice


