
The purpose of this letter is to clarify the second paragraph of the Safety Assessment which supports proposed license amendments submitted by PPL Susquehanna, LLC (PPL) on January 13, 2000 (reference). This letter is being submitted at the request of the NRC project manager to facilitate the review of the proposed license amendments.

The paragraph may imply that the associated FSAR change, that will bring the Pressure/Temperature (P/T) figure legends in the FSAR and Technical Specifications into conformance with one another, was approved and incorporated into the FSAR prior to having the proposed license amendments approved by the NRC. This FSAR change has not been implemented pending NRC approval of the proposed license amendments. Upon receipt of the approved license amendments PPL will incorporate it into the next revision of the FSAR in accordance with 10CFR50.71(e).






