I realize there are always more than one side to every story. I would love to see the NRC's story but I understand that the NRC has not released its report. I have heard second hand that it is not willing to release the OI investigation. If the NRC is willing to release its report, then consider this a FOIA request for the entire OI report with all attachments and interviews.

The DOL report does not support my conclusion, it is the ONLY documented conclusion made available to the public.

I have seen two reasons from the NRC related to the investigation. The first is what you told me in that the NRC completed its investigation and stands by its conclusion of no discrimination. I also understand that the NRC completed its investigation before Mr. Aiken's security clearance was removed and before he was fired. Published in the Times yesterday, was a statement by the NRC that infers the NRC never completed the investigation as it did not want to spend any more taxpayer dollars. Are these statement both accurate?

In the past, when I have made similar requests, the NRC responds with a proposed bill for hundreds of dollars.
