Based on the information submitted by the licensee on March 10, 2000, and information discussed between the staff and the licensee during a telephone conference on September 5, 2000, the NRC staff concluded that additional information is required for the completion of the review.

Generic Letter 96-03 which describes the pressure temperature (PT) limit curve relocation process to the PTLR requires that the PT and low temperature overpressure protection limits be determined using methodologies approved by the NRC. The March 10, 2000, submittal and analysis is based on WCAP-12795, Revision 3, and WCAP-12794, Revision 4, both of which use the FERRET code, which has not been approved. In order for the staff to complete this review, the licensee should provide the necessary analysis using previously approved methodologies or submit their proposed methodologies for review.
