Comments: There are some very serious Environmental Justice concerns with the Skull Valley plan. As you know, in the back of the DEIS (Appendix F, Exhibit F.3) are the Site Selection / Evaluation Forms which ask several questions designed to evaluate which areas would be better suited for the facility. One of the questions asks whether the area "Has a vote of host population on record in support of this facility", and the Form answers "yes". Well, according to Tribal General Council member, Sammy Blackbear, there never was a vote, making this untrue. This is an extremely important issue that the NRC may not have been aware of. The NRC should also be aware of how the lease was signed. About one-third of the Goshute governing body has filed a lawsuit alleging corruption and negligence, stating that the Tribal Chairman signed the lease without consulting the tribe's governing body. These tribal members also allege that specific details of the agreement (like what kind of f!

! financial compensation has been offered) have not been shared by the Tribal Chairman. Also according to Sammy Blackbear, the money from PFS is (which is in the hands of the Chairman), is only being offered to the tribal members who support the lease. Since most of the tribal members that live on the reservation DON'T support the waste (most that do DON'T actually live on the reservation), the majority of the PFS money will actually not be going to the people who live on the reservation! I realize that the NRC may not have been aware of these issues, but it is very important you do understand them, and I would hope that you would not allow a "lease" to go through under such circumstances.
