Dear Sir/Madam:

This letter is being issued to provide PECO Energy's written commitment to participate in the Optional ETS methodology as requested in Regulatory Issue Summary 2000-11, NRC Emergency Telecommunications System, dated June 30, 2000.

PECO Energy will perform the following work to conform to the NRC guidelines for replacing the FTS2000. This work is voluntary and will be performed at the following sites:

- Limerick Generating Station
- Peach Bottom Atomic Power Station

By December 6, 2000, each of the above listed sites will convert the existing FTS 2000 circuits to regular PBX extensions that are supported by the PBX that is dedicated for each site. Each telephone will be labeled with the new 800 numbers that have been provided by the NRC.

PECO Energy's Emergency Preparedness group will document these changes.

The telephones that are to be changed by site are as follows:

Limerick Generating Station

- ENS - Early Notification System
- HPN - Health Physics Network
- RSCL - Reactor Safety Counterpart Link
- PMCL - Protective Measures Counterpart Link
- MCL - Management Counterpart Link
- ERDS - Emergency Response Data System
