PPL Susquehanna LLC will reference this supplement and the corresponding topical report in support of an amendment request to increase the rated thermal power levels of SSES Units 1 and 2. This amendment request is currently planned to be submitted by the end of September. Approval will be requested by April 2001. This topical report is being provided to the NRC on the SSES Dockets in order that NRR can begin the review of the supplement to the topical report necessary to support the forthcoming amendment requests.

The supplement evaluates two systems. SSES will be installing the LEFM✓™ system and thus requests review of only the LEFM✓™ system to support a 1.4% increase in rated thermal power level.

As this submittal contains information proprietary to Caldon, it is supported by an affidavit signed by Caldon, the owner of the information. The affidavit sets forth the basis on which the information may be withheld from public disclosure by the Commission and addresses with specificity the considerations listed in paragraph (b)(4) of 10CFR2.790 of the Commission's regulations.
