The purpose of this modification is to provide an equitable adjustment and direct the contractor to furnish and install 33 new 2X4 3 tube T8 electronic ballast 18 cell parabolic lay-in fixtures which is the alternate bid price as described in Note D-1, TL-1.1 of the drawings.

As a result of this change order the amount of \$4,253 is insert in B.3.2. Accordingly, the contract is hereby modified as follows:
