Contract number NRC-10-96-155 is hereby modified to provide an equitable adjustment for the changes directed in modification number forty-eight (48) to the contract drawings. The changes to the fifth floor were as follows:

1. Install seventeen (17) additional duplex outlets.
2. Install two (2) additional Independent Ground (IG) outlets.
3. Relocate six (6) additional light fixtures.
4. Install four (4) additional light fixtures.
5. Install one (1) additional single pole light switch.
6. Install one (1) return air grille.
7. Delete installation of 4 8/C furniture junction box connectors.

As a result of this modification, Section B.4 CONSIDERATION AND OBLIGATION-- FIRM FIXED PRICE is hereby modified to increase the fixed price of the contract by \$1,634 from \$5,416,474 to \$5,418,108.

In consideration of Modification Number Sixty-One (61), the Contractor hereby releases the Government from any and all liability under this contract for further equitable adjustments attributable to such facts or circumstances giving rise to the Contractor's proposal for adjustment dated March 23, 1998.

Except as provided herein, all other terms and conditions of the contract remain unchanged and in full force and effect.
