

The purpose of this modification is to deobligate excess funds in the amount of \$3,484.97 from the contract, thereby reducing the contract ceiling from \$292,701.66 to \$289,216.69 and the obligated amount from \$112,552.00 to \$109,067.03. Accordingly, the contract is hereby modified:
