

I am writing to request that you delineate for me the rulemakings that the Nuclear Regulatory Commission (NRC) may propose or complete in the closing months of the Clinton Administration. Accordingly, in order to understand fully the scope of possible regulatory actions the NRC is considering, I am requesting, pursuant to Rules X and XI of the U.S. House of Representatives, that you provide the Committee with a list of all pending rulemakings and also identify those rulemakings that you expect the NRC to propose, finalize or otherwise take any action on before the end of the year. Please provide the above requested information by October 12, 2000.
