Application for Order and Conforming Amendments for License Transfer

In the above referenced application, Northeast Nuclear Energy Company (NNECO) and Dominion Nuclear Connecticut, Inc. (DNC) applied for NRC's consent and conforming license amendments to transfer the operating licenses for the Millstone Nuclear Power Station (Millstone) Units 1, 2 and 3 to DNC. Exhibit H to that application provided a post-acquisition DNC organization chart. This supplement provides additional information concerning that organization and revises Exhibit H accordingly. The additional information is provided below and a revised Exhibit H is provided in Attachment 1 to this letter.

Mr. David A. Christian, who was originally identified as the Senior Vice President of DNC, will have the title Senior Vice President – Nuclear Operations and will also serve as its Chief Nuclear Officer. Messrs. Leon J. Olivier and Raymond P. Necci, who are currently officers of NNECO, will remain with Millstone as it is integrated into DNC. Mr. Olivier will assume the position of Senior Vice President – Connecticut Nuclear Operations, and Mr. Necci will assume the position of Vice President – Technical Services. Mr. Eugene S. Grecheck, who previously was Virginia Power's Site Vice President for Surry Nuclear Power Station, will serve as the operations officer for Millstone during the transition period and will, upon transfer of the Millstone licenses to DNC, assume the position of Vice President – Generation. A copy of Mr. Grecheck's resume demonstrating his qualifications is provided in Attachment 2.







## **Eugene S. Grecheck**

Eugene S. Grecheck joined Virginia Power in June 1975. He is a native of Schenectady, NY.

Grecheck received his bachelor's degree in Physics from Rensselaer Polytechnic Institute in 1974, a MS Nuclear Engineering degree from RPI in 1975, an MBA from Virginia Commonwealth University in 1981, and an MBA upgrade from Syracuse University in 1996. He is also a 2000 graduate of The Executive Program (TEP) at the Darden Graduate School of Business Administration at the University of Virginia.

Grecheck was licensed by the USNRC as a Senior Reactor Operator at Surry Power Station in 1983.

He graduated in 1996 from the INPO Senior Plant Management Course.

Grecheck joined Virginia Power in 1975 as a licensing engineer. He was appointed Supervisor-Engineering in 1981, Superintendent-Projects in 1982, and Superintendent-Technical Services in 1985. Grecheck was promoted in 1987 to the position of Assistant Station Manager-Nuclear Safety & Licensing. In 1990 he moved to the corporate office in the position of Manager-Nuclear Engineering, in 1991 to Manager-Inservice Inspection/Non-destructive Examination and Engineering Programs, and in 1994 was named Manager-Design Engineering and Support. In 1996 he assumed the position of Assistant Station Manager-Operations & Maintenance, at North Anna Power Station, and in 1998 was promoted to Site Vice President at Surry Power Station. As Site Vice President, Grecheck was responsible for all aspects of safe, reliable operation of two 850 MW PWRs.
