1.0 PURPOSE

1.1 To provide instructions for methods of notification of personnel and provide list of names and telephone numbers for: [NOCS 400, 1954]

- o Technical Support Center Activation (Enclosure 1)
- o Operational Support Center Activation (Enclosure 2)
- o FPC Corporate and Generating Complex (Enclosure 3)
- o Offsite-Local, State, Federal (Enclosure 4)
- o Violent Weather Committee personnel (Enclosure 5)

1.2 To provide instructions to obtain Emergency Team Rosters from the Training Information System (TIS).

3.0 PERSONNEL INDOCTRINATION

NOTE: A safety assessment was performed for the procedure and is determined to be outside the scope of 10CFR50.59.

3.1 DEFINITIONS

Activation - To provide notification to emergency response personnel of the need to respond to the TSC/OSC for staffing and operation.

Notification - To provide notification of an emergency condition to emergency response personnel.

Operational - The minimum functions and communication links are established, required equipment is in proper working order, and the EC has assumed responsibility and authority for the emergency condition.

3.2 RESPONSIBILITIES

- 3.2.1 The Emergency Coordinator notifies Security to ensure necessary notifications are completed during the declared emergency condition at CR-3.**
- 3.2.2 Nuclear Security ensures emergency response personnel are notified in accordance with this procedure.**
- 3.2.3 The Nuclear Operations Training Specialist provides data entry, verification, generation and distribution of Emergency Team Rosters.**
- 3.2.4 The Supervisor, Nuclear Operations Training Administration ensures overall accuracy and effectiveness of TIS for Emergency Team Rosters.**
- 3.2.5 The Manager, Radiological Emergency Planning or designee performs quarterly reviews of Emergency Roster Call Lists and submits changes as necessary.**

3.3 **LIMITS & PRECAUTIONS**

- 3.3.1 The Emergency Group Pager system is not intended to take the place of manual phone notification of emergency personnel during backshift, weekend or holidays.
- 3.3.2 Once the TSC is operational, the Emergency Coordinator determines the number of additional personnel to cope with the emergency and ensures appropriate calls are made from the Emergency Roster Call Lists. [NOCS 1870]

4.0 **INSTRUCTIONS**

4.1 **INSTRUCTIONS FOR NOTIFYING TSC AND EOF STAFF**

- 4.1.1 Activation of the TSC and EOF is performed by Nuclear Security when the Emergency Coordinator notifies Nuclear Security to activate either the TSC or EOF.
- 4.1.2 Immediately upon request from the Emergency Coordinator to activate the TSC or EOF, Nuclear Security will:
 - 4.1.2.1 **All Shifts**

GO TO Section 4.3.1 for the TSC and/or 4.3.2 for the EOF as requested, **AND ACTIVATE** the emergency group pagers.
 - 4.1.2.2 **Backshift, Weekend or Holiday**

In addition to activation of emergency group pages for the TSC or EOF, **BEGIN** phone notification of the TSC or EOF staff using the weekly on-call list.
- 4.1.3 **IF** phone contact is not made from the weekly on-call list for the TSC, **THEN GO TO** Enclosure 1 and **CONTACT** a minimum of one person from the positions you were unable to contact.
- 4.1.4 **UNLOCK** the entrance doors to the TSC.
- 4.1.5 **IF** pagers do not activate, **THEN** begin additional notifications of personnel from Enclosure 1, page 2.

NOTE: Current computer printouts of Emergency Team Rosters are located in the Control Room and in the Operational Support Center.

4.2 INSTRUCTIONS FOR OBTAINING EMERGENCY TEAM ROSTERS
[NOCS 7450, 9819]

The following instructions may be used from a Network personal computer. The printers designated to print reports are identified within the Report Module as discussed below.

NOTE: If any problems are experienced with the execution of the report(s), contact the "HELP" desk.

4.2.1 Printing Reports

4.2.1.1 OPEN Windows from a Network computer.

4.2.1.2 Double click on the Training Information System (TIS) icon. The TIS Window will appear.

4.2.1.3 CLICK on "BROWSE."

4.2.1.4 In the TIS Window, CLICK on the Report Submission icon. The Report Menu Selection and Submission Window will appear.

4.2.1.5 Click on "Team Reports."

4.2.1.6 HIGHLIGHT the "Nuc Emergency Team 30/60/90 Report" under the "Quick Pick Reports."

4.2.1.7 SUBMIT the report.

4.2.1.8 ENTER the name of the person requesting the report, the number of copies desired, the printer location, the appropriate mail code, and today's date.

4.2.1.9 SUBMIT the report. A message box will appear on the screen informing you that the report has been scheduled to print. The report will be printed on the selected printer.

4.2.2 Viewing Team Qualifications on the PC Screen

4.2.2.1 OPEN Windows.

4.2.2.2 Double click on the Training Information System (TIS) icon. The TIS Window will appear.

4.2.2.3 CLICK on "BROWSE."

4.2.2.4 In the TIS Window, CLICK on the Qualifications icon. The Qualifications Search Criteria Window will appear.

4.2.2.5 Individual Information

4.2.2.5.1 ENTER the name or SS# of individual and click on Search. A list of individuals meeting the search criteria will appear on the screen.

4.2.2.5.2 PLACE cursor on individual name and PRESS INQ Teams. Individual qualifications and expiration dates will appear.

4.2.2.6 Team Information

4.2.2.6.1 ENTER "NUC" under item.

4.2.2.6.2 ENTER description such as Repair, Accident, etc. depending on team desired.

4.2.2.6.3 PLACE cursor on appropriate team.

4.2.2.6.4 PRESS Search button. A list of qualified individuals will appear.

4.3 NOTIFICATION METHODS

4.3.1 TSC - Activation of Emergency Group Pagers

NOTE: To correct an entry error, press "Exit" and re-enter.

NOTE: There is a backup Quikpager keyboard in the Technical Support Center.

To activate the Emergency Group pagers, COMPLETE the following:

- 4.3.1.1 OBTAIN the verification pager in the Nuclear Security Operations Center.
- 4.3.1.2 TURN on verification pager. (You will receive confirmation beeps.)
- 4.3.1.3 TYPE "TSC" on Quikpager keyboard.
- 4.3.1.4 PRESS "Enter" key.
- 4.3.1.5 PRESS "M" (for message) on keyboard.
- 4.3.1.6 PRESS "F1" key (stored message instructing personnel to staff the TSC).
- 4.3.1.7 PRESS "Enter" key. (Message sent when original screen appears.)
- 4.3.1.8 IF pagers fail to activate on day shift,
THEN BEGIN notification of TSC staff using the "Office" numbers listed in Enclosure 1. CONTACT a minimum of one person from each of the first six functions.
- 4.3.1.9 TYPE "DAT" on Quikpager keyboard.
- 4.3.1.10 PRESS the "ENTER" Key.
- 4.3.1.11 PRESS "M" on Keyboard.
- 4.3.1.12 PRESS "F2" key (stored message instructing EOF Dose Assessment Team to report to EOF)
- 4.3.1.13 PRESS "ENTER" Key.

NOTE: The repeat page may be performed from the TSC back-up Quikpage Unit located in the Communications Room.

4.3.1.14 REPEAT sections 4.3.1.3 through 4.3.1.7 when paging cycle ends.

4.3.1.15 RETURN to Section 4.1.2.2 and complete as appropriate.

4.3.2 EOF - Activation of Emergency Group Pagers

NOTE: To correct an entry error, PRESS "Exit" and RE-ENTER.

NOTE: There is a backup Quikpager key board in the Technical Support Center.

To activate the Emergency Group pagers, COMPLETE the following:

4.3.2.1 OBTAIN the verification pager in the Nuclear Security Operations Center.

4.3.2.2 TURN ON verification pager. (You will receive confirmation beeps.)

4.3.2.3 TYPE "EOF" on Quikpager keyboard.

4.3.2.4 PRESS "Enter" key.

4.3.2.5 PRESS "M" (for message) on keyboard.

4.3.2.6 PRESS "F2" key (stored message instructing personnel to staff the EOF).

4.3.2.7 PRESS "Enter" key. (Message sent when original screen appears.)

4.3.2.8 REPEAT sections 4.3.2.3 through 4.3.2.7 when paging cycle ends.

4.3.2.9 NOTIFY EOF Director to notify EOF staff.
