On October 19, 2000, Kaiser Aluminum (Kaiser) notified the U.S. Nuclear Regulatory Commission (NRC) that it has completed the final status survey for Survey Unit 1, in accordance with the remediation plan (RP). The letter states that soil sample analyses indicate that Survey Unit 1 meets the remediation limits established in the RP. It is also stated that Kaiser would like to backfill the excavations, made during remediation, as soon as practicable. Kaiser acknowledges that any backfilling done before NRC approval of the Final Status Survey Report (FSSR) will be done at its own risk.

NRC is not opposed to Kaiser backfilling excavations at its own risk. If NRC identifies deficiencies in the FSSR, it will be necessary for Kaiser to correct the deficiencies even if it means re-excavation.
