The Commission has issued Amendment No. 13 to Facility Operating License No. DPR-50 for the Three Mile Island Nuclear Station, Unit 1. The amendment consists of changes to the Technical Specifications in accordance with your request dated January 16, 1976, as supplemented February 13, 1976.
